#### **SERVICE AGREEMENT**

The following are the salient terms of the Service Agreement:

- 1. Supreme Right shall provide the services of (i) developing the online platform for Grandeur for its B2C (business-to-customer) electronic commerce business of selling the soft bedding products identified by Grandeur; and (ii) arranging for provision of services for operating and maintaining the online platform for the service term of one year from the date of signing of the Service Agreement;
- 2. Grandeur shall be responsible for manufacturing, supplying, packaging and delivery of the soft bedding products directly to the customers after placement of orders on the online platform; and
- 3. Grandeur shall pay to Supreme Right (i) a lump sum of HK\$500,000; and (ii) a sum which shall be equal to 5% of the proceeds of sales generated on the online platform for each calendar month.
