CHANGE OF COMPANY NAME

The Board is pleased to announce that the English name of the Company has been changed from “M Dream Inworld Limited” to “GET Holdings Limited” and “智易控股有限公司” has been adopted as the new Chinese name of the Company to replace “聯夢活力世界有限公司” for identification purposes only.

CHANGE OF STOCK SHORT NAMES

The stock short names for trading in the Shares on the Stock Exchange will be changed from “M DREAM INWORLD” to “GET HOLDINGS” in English and from “聯夢活力世界” to “智易控股” in Chinese, both with effect from 9:00 a.m. on 24 November 2014.

Reference is made to the announcement of M Dream Inworld Limited (now known as GET Holdings Limited) (“**Company**”) dated 2 September 2014 and the circular (“**Circular**”) of the Company dated 19 September 2014 in relation to the Change of Company Name. Capitalised terms used in this announcement shall have the same meanings as defined in the Circular unless the context herein requires otherwise.

CHANGE OF COMPANY NAME

The Board is pleased to announce that the English name of the Company has been changed from “M Dream Inworld Limited” to “GET Holdings Limited” and “智易控股有限公司” has been adopted as the new Chinese name of the Company to replace “聯夢活力世界有限公司” for identification purposes only.

Subsequent to the passing of a special resolution in relation to the Change of Company Name by the Shareholders at the SGM held on 15 October 2014, the Certificate of Incorporation on Change of Name was issued by the Registrar of Companies in Bermuda on 23 October 2014 certifying that the Company has changed its English name to “GET Holdings Limited” with effect from 21 October 2014, the date of registration as set out in the Certificate of Incorporation on Change of Name issued by the Registrar of Companies in Bermuda. The new Chinese name “智易控股有限公司” has also been adopted as the new Chinese name of the Company to replace “聯夢活力世界有限公司” for identification purposes only.

The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 14 November 2014 certifying that the new English name of the Company has been registered in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

CHANGE OF STOCK SHORT NAME

The stock short names for trading in the Shares on the Stock Exchange will be changed from “M DREAM INWORLD” to “GET HOLDINGS” in English and from “聯夢活力世界” to “智易控股” in Chinese, both with effect from 9:00 a.m. on 24 November 2014.

There will not be any arrangement for exchange of the existing certificates of securities for new certificates bearing the new name of the Company. New certificate of securities will be issued only in the new name of the Company.
