(i) The Capital Reorganisation was effective on 24 March 2015. Every 10 unissued and issued Shares of HK\$0.01 each were consolidated into one Consolidated Share of HK\$0.10 each. Meanwhile, the issued share capital of the Company was reduced through a cancellation of the paid-up capital to the extent of HK\$0.09 on each of the issued Consolidated Shares such that the nominal value of each issued Consolidated Share was reduced from HK\$0.10 to HK\$0.01 and the authorized but unissued Consolidated Shares of HK\$0.10 each will be sub-divided into 10 New Shares of HK\$0.01 each.

(ii) As a result of the Capital Reorganisation, the issue price of the Tranche II Performance Shares and the Shortfall Performance Shares have been adjusted to HK\$4.32 per New Share (subject to further adjustment) and the maximum number of the Tranche II Performance Shares/Shortfall Performance Shares to be allotted have been adjusted to 18,420,496 New Shares (subject to further adjustment).
