UPDATE OF ISSUE OF NOTES; AND CONNECTED TRANSACTION — PAYMENT OF PLACING COMMISSION

Reference is made to the announcement of GET Holdings Limited (“**Company**”) dated 26 June 2015 (“**Announcement**”) in which it announced its proposed placing of 10% unsecured loan notes (“**Notes**”) maturing on the second anniversary of the issue date of the Notes to be issued by the Company (“**Placing**”). Capitalised terms used in this announcement shall have the same meaning as defined in the Announcement.

The Placing Period shall last for a period commencing on the day immediately following the date of the Placing Agreement of 26 June 2015 and up to (and including) the date falling on the 15th day of the sixth month after the date of the Placing Agreement.

As announced in the announcements of the Company dated 3 August 2015, 17 August 2015 and 1 September 2015, the Notes in an aggregate principal amount of HK\$15,000,000 had been issued to certain placees who subscribed for the Notes during the period from 27 June 2015 to 24 August 2015. The aggregate placing commission paid by the Company to the Placing Agent was HK\$750,000.

The Board is pleased to announce that on 15 September 2015, the Notes in an aggregate principal amount of HK\$2,500,000 have been issued to certain placees (“**Placees**”) who subscribed for the Notes during the period from 25 August 2015 to 7 September 2015 (“**Subscriptions**”). The placing commission paid by the Company to the Placing Agent for the Subscriptions is HK\$125,000.

To the best of the Directors’ knowledge, information and belief and having made all reasonable enquiries, the Placees are independent of, and not connected with the Company, and its connected persons (within the meaning under the GEM Listing Rule) and their respective associates (within the meaning of the GEM Listing Rules).
