INSIDE INFORMATION – UPDATE ON PERFORMANCE OF SECURITIES INVESTMENT BUSINESS SEGMENT

This announcement is made by GET Holdings Limited (“**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10(2)(a) of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (“**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (“**Board**”) of directors (“**Directors**”) of the Company wishes to inform the shareholders of the Company and potential investors that, based on the preliminary review and analysis of the latest available unaudited financial information of the securities investment business of the Group (“**Securities Investment Business**”), the Group is expected to record a segment profit for the Securities Investment Business of approximately HK\$200,000 for the nine months ended 30 September 2021 (“**2021 Third Quarterly Period**”) as compared to the segment loss for the Securities Investment Business of approximately HK\$12,765,000 for the nine months ended 30 September 2020 (“**2020 Third Quarterly Period**”). The expected segment profit of the Securities Investment Business for the 2021 Third Quarterly Period was primarily attributable to the net fair value gain on financial assets at fair value through profit or loss of approximately HK\$253,000 for the 2021 Third Quarterly Period (2020 Third Quarterly Period: loss of approximately HK\$8,729,000).

As the Group is still in the process of preparing and finalising its unaudited consolidated financial results for the 2021 Third Quarterly Period, the information contained in this announcement is only based on a preliminary assessment made by the Board with reference to the information currently available. It is not based on any data or information that has been audited or reviewed by the auditors of the Company. There may be adjustments following further review and finalisation of the unaudited consolidated financial results of the Group for the 2021 Third Quarterly Period by the Board.
