The board ("Board") of directors ("Directors") of the Company wishes to inform the shareholders of the Company and potential investors that, based on the preliminary review and analysis of the latest available unaudited financial information of the Group, the Group is expected to record a net loss of not more than HK\$3.0 million for the six months ended 30 June 2023 ("2023 Interim Period") as compared to the net profit of approximately HK\$0.45 million for the six months ended 30 June 2022 ("2022 Interim Period"). The expected loss for the 2023 Interim Period was primarily the combined effects of (i) segment profit of the software business of the Group of approximately HK\$4.7 million (2022 Interim Period: profit of approximately HK\$11.9 million) of which the decrease in profit was primarily attributable to the decrease in revenue in that segment due to the fierce competition in the software industry; (ii) segment loss of the securities investment business of the Group of approximately HK\$2.2 million (2022 Interim Period: loss of approximately HK\$3.5 million); (iii) segment profit of the corporate management solutions and information technology contract services business of the Group of approximately HK\$0.61 million (2022 Interim Period: profit of approximately HK\$0.39 million); (iv) segment loss of the business-to-customer online sales platform and business-to-business product trading business of the Group of approximately HK\$0.03 million (2022 Interim Period: loss of approximately HK\$0.90 million); and (v) off-set by other corporate expenses of approximately HK\$5.4 million (2022 Interim Period: approximately HK\$5.8 million).
